

President remarks (Brooks Higginbotham)

- Provided information on or updates on the following initiatives
 - College Board-AP exam meeting next week. Conversation about our role and the focus on African American Studies, not just African American history

 - White House-programming

 - There may be an automatic way to filter out inappropriate language in the back end of YouTube
 - We may just want to use the current community standards of YouTube versus creating new ones
 - Browne-Marshall said that she would be willing to help Governance and ASALH
 TV committee with these policies

- Kimble showed and reviewed the Padlet dashboard about the work being done in the Program cluster. Duncan suggested Trello as a way for the cluster and/or committee to do work and to create something similar if they wanted to track projects
- Attention was made in regard to the White House programming (Juneteenth programming, next year programming, potential conference collaboration)
- Dunn and Cyrus updated about the Woodson House construction
- College Board partnership (Cyrus)
 - Reviewed our role in the partnership-identify people for their advisory board and get syllabi. People need to be in a variety of disciplines
 - Concerns were had by some: about the content of the course, the teacher training component, if we were being exploited/used by the College Board, and demographics of who is taking the course
 - o Revamp our Speaker's Bureau so this information is more at hand
 - Benefits shared included potential partnerships with National Council of Black Studies, and the opportunity to promote Black Studies in secondary schools and as a discipline

Motion: Lionel Kimble moved the question to end debate.
