begun developing a strategic plan to increase diversity, strengthen relationships across campus, Providence, and the wider academic community. As an adviser to the University Librarian, I have been an integral part of strategic planning and relationship building for the library across the campus, in the region, and with other academic and institutions. I have led the efforts to improve onboarding of new staff, developed series to introduce newly restructured and existing departments to campus community, and serve as an adviser to special collections and digital publishing initiatives. Additionally, I am developing the structure for an emerging library leaders' fellowship program that recently received funding from the Institute of Museum and Library Services.

Prior to joining Brown University Library, I was the Johanna- Marie Fraenkel Curator for Race and Ethnicity at Harvard University's Arthur and Elizabeth Schlesinger Library on the History of Women in America. In that position, I lead the library's efforts to diversify the collections and programming to be more inclusive of racial and ethnic populations across the country. There, I identified gaps in the collections and worked to develop relationships with financial and collection donors and led the effort to engage community members in the greater Boston Region and across the country to expand collections and programs. I consulted with scholars within the Harvard community and other universities to advise the library as we expand our collecting scope and rewrite our collections development plan. I worked with archivists and curators, both within Harvard Library and other repositories, to develop partnerships to increase access to collections about marginalized people, particularly women.

Before joining the Schlesinger Library, I served as Assistant Curator of Manuscripts at Howard University's Moorland-Spingarn Research Center. In addition to my work with the Harvard Library and the Howard University Library System, I have worked with the Maryland-National Capital Park and Planning Commission which is a non-profit bi-county agency established more than eighty years ago in the Washington, D.C. area. There I created exhibitions and public programs to educate and promote the history of Prince George's County. These programs were created for all ages and education levels including senior citizens, college, high school and primary school students and the public.

Major Accomplishments: In 2017, I was part of the organizing team and a participant in a twoday workshop, A More Complete Record: A Case for Archival Partnerships. The workshop brought together archivists, librarians, curators, historians, and the public to discuss how technology can be used to facilitate partnerships to increase access to related to African American history. As an organizer, I was able to contribute to the structure and direction of the workshop. As a participant, I was able to speak with and facilitate the conversation with archivists and librarians who work on the frontlines about their challenges and achievements. The workshop helped to move the conversation about institutional partnerships, collections access, and building trust forward for participants including, Harvard Library, Historically Black Colleges and University libraries, historically white institutions, private collections, and the Federal Government.

To raise visibility to the Schlesinger Library's diversity efforts, I headed a committee that planned and held an evening program. A Signature Event: Honor Black Women of Boston engaged a group that had previously been excluded from the traditional collecting efforts. This

event not only highlighted new acquisitions, but it also signaled to the Harvard and Boston communities previously marginalized group was welcome. A result of this event was the identification of new potential donors and organizational partners. In addition to the efforts to increase collections of local women, I led the effort to acquire the papers of national figures like Angela Davis. I was also part of the committees planning the conference and curating the exhibition about Davis in the fall of 2019.

Dr. Zebulon Vance Miletsky is an Associate Professor of Africana Studies and History at Stony Brook University. Dr. Miletsky, is an historian specializing in recent African-American History, Civil Rights and Black Power, Urban History, Mixed Race and Biracial identity, and Hip-Hop Studies. His research interests include: African-Americans in Boston; Northern freedom movements outside of the South; Mixed race history in the U.S. and passing; and the Afro-Latin diaspora. He is the author of numerous articles, reviews, essays, and book chapters. Originally from Boston, Massachusetts Miletsky received his Ph.D. in African-American Studies with a concentration in History from the W.E.B. Du Bois Department of Afro-American Studies at the University of Massachusetts at Amherst in 2008. There, he was trained as a historian by some of the best thinkers in the field of African-American Studies, many of whom are veterans of the Civil Rights and Black Power movements of the 1950s, 60s and 70s and beyond. Miletsky is a member of Calvary Fellowship AME Church located in the Bedford-Stuyvesant section of Brooklyn, NY, where he attends with his wife and two sons. He serves as President of the Men's Ministry and its "Sons of Allen" Chapter in the 1st AME Episcopal District. He is also a Church Trustee, and he lives in the "Bushwick" section of Brooklyn, NY.

Major Accomplishments:

His articles have appeared in the *Trotter Review*, the *Historical Journal of Massachusetts*, the *Journal of Civil and Human Rights* and the *Journal of Urban History*. He is a regular contributor to the award-winning blog Black Perspectives, hosted by the African-American Intellectual Historical Society (AAIHS) for which he co-authored "How Displacement and Gentrification are Remaking Boston" (2017). He has written op-eds for Diverse Issues in Higher Education, BK Nation and is a columnist for the BK Reader--a weekly free newspaper in Brooklyn's Bedford-Stuyvesant neighborhood. He has received fellowships from the Northeast Consortium for Faculty Diversity and Case Western Reserve University, where he was, respectively, a Minority Dissertation Fellow at Monmouth University and a Post-Doctoral Fellow in African-American Studies in the Department of History. Miletsky has given a Tedx Talk at Stony Brook University entitled "Tracing Your 'Routes" featured on <u>Ted.com</u>. He has appeared on Huffington Post

Live, various radio shows including WBAI NYC 99.5 FM radio and WEAA 88.9 FM in Baltimore and interviewed for the "Multiracial Family Man" Podcast. He has been quoted by NBC News, <u>TheRoot.com</u>, and many others. Miletsky was awarded the Game Changers' Award from the Long Island Area NAACP branches at their Freedom Luncheon in 2020.
